- Competitors of the categories Adult Male/Female, Junior Male/Female, and Veterans must wear an ITF Dobok (not limited to any manufacturer, any official brand is allowed).
- All competitors must have a **BLUE** and **RED** set of an approved type of safety equipment for sparring (not limited to any manufacturer, any official brand is allowed). Other colors will not be allowed.



- According to the ITF rules, punches to the high section are allowed for all ages*
- All athletes will participate at their club's responsibility.
- The organization committee is not responsible for equipment loss or injuries before, during, or after the tournament.
- The clubs and the athletes should care about their complete insurance.
